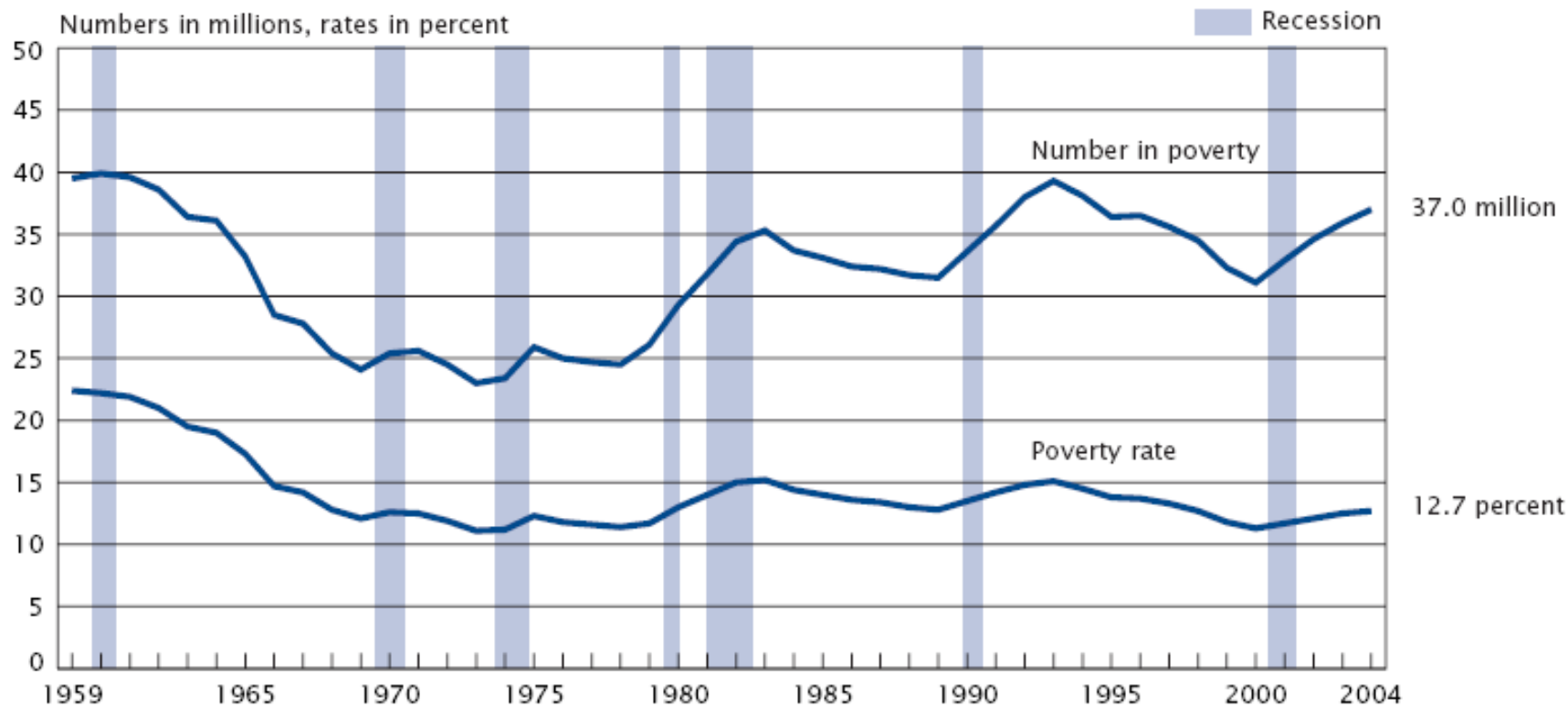

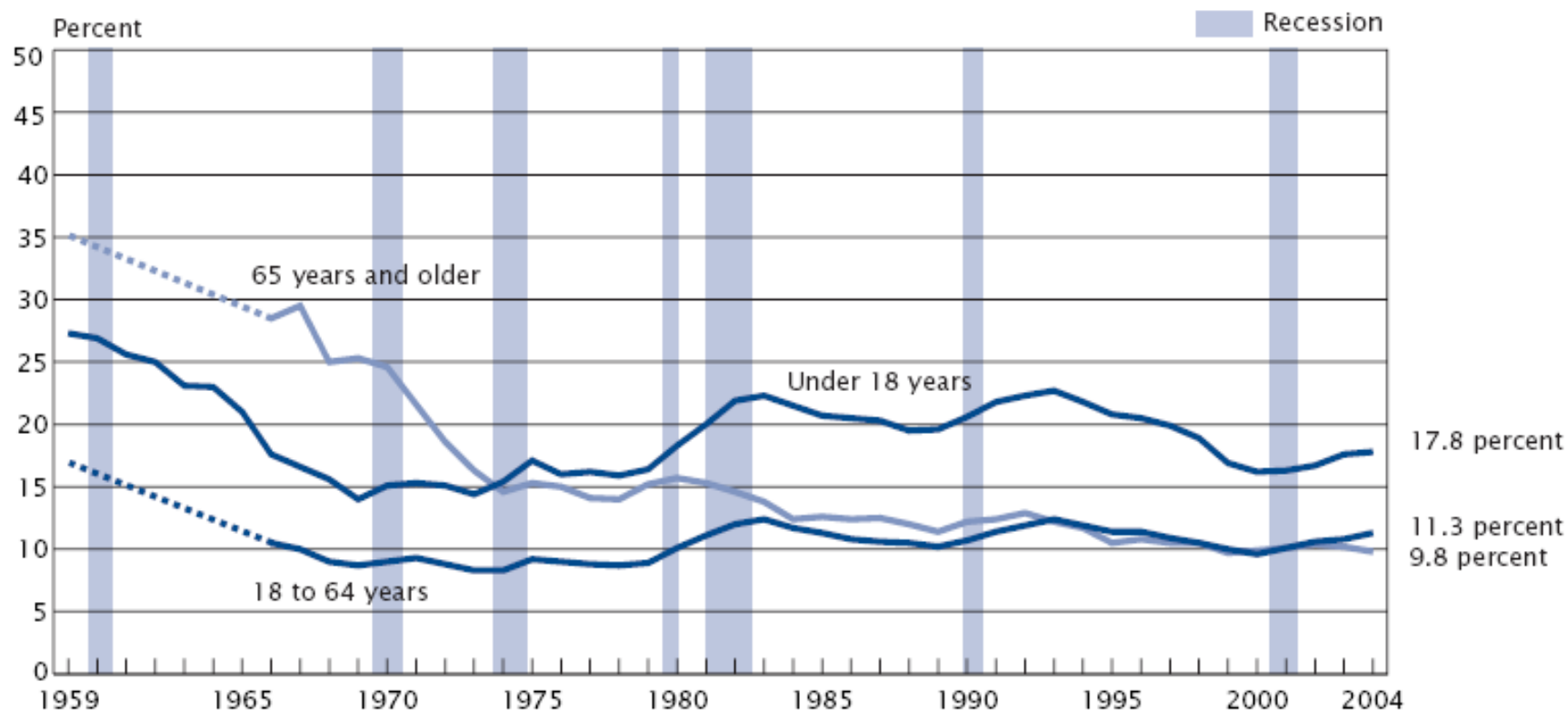

Poverty Rates by Age: 1959 to 2004

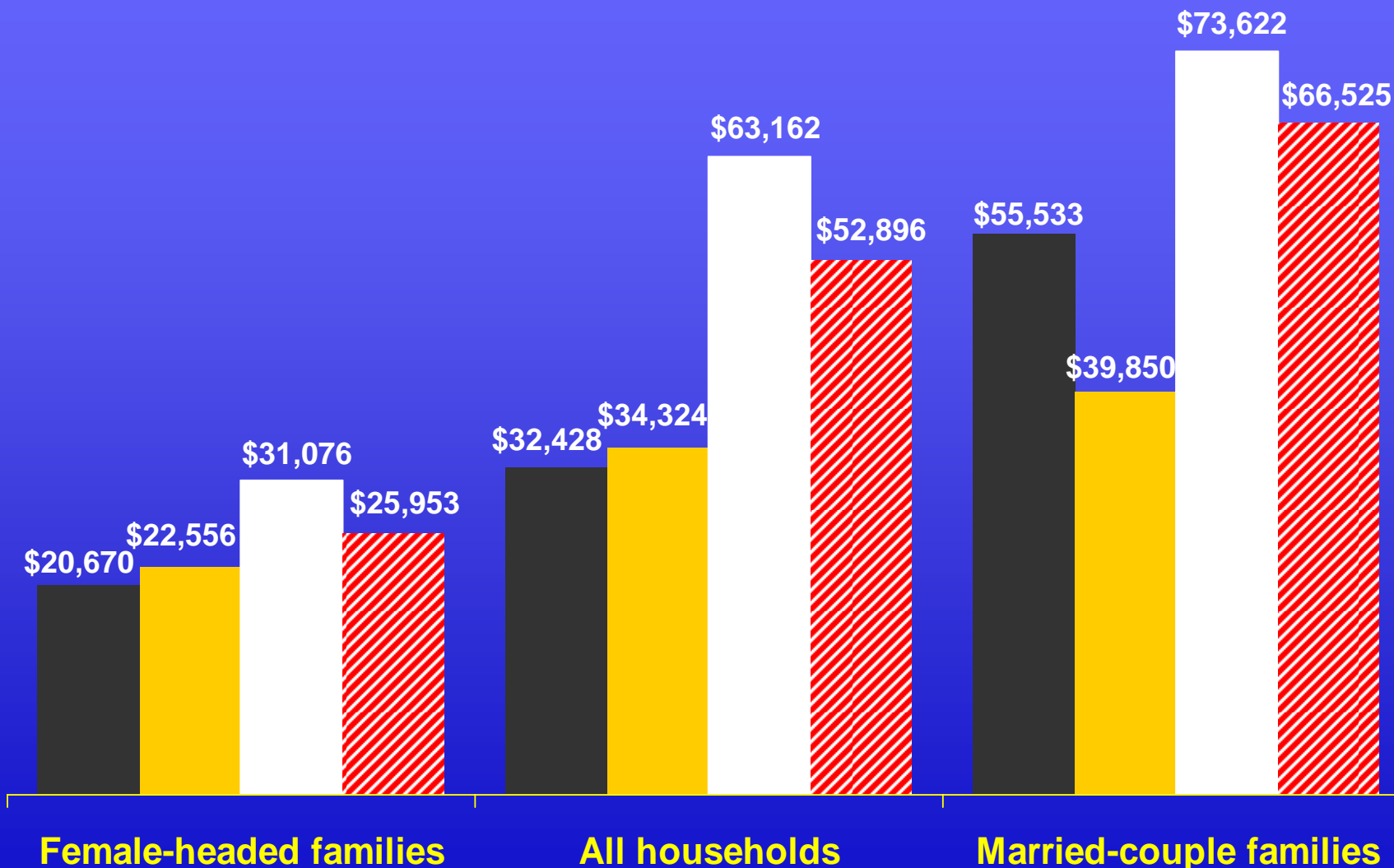

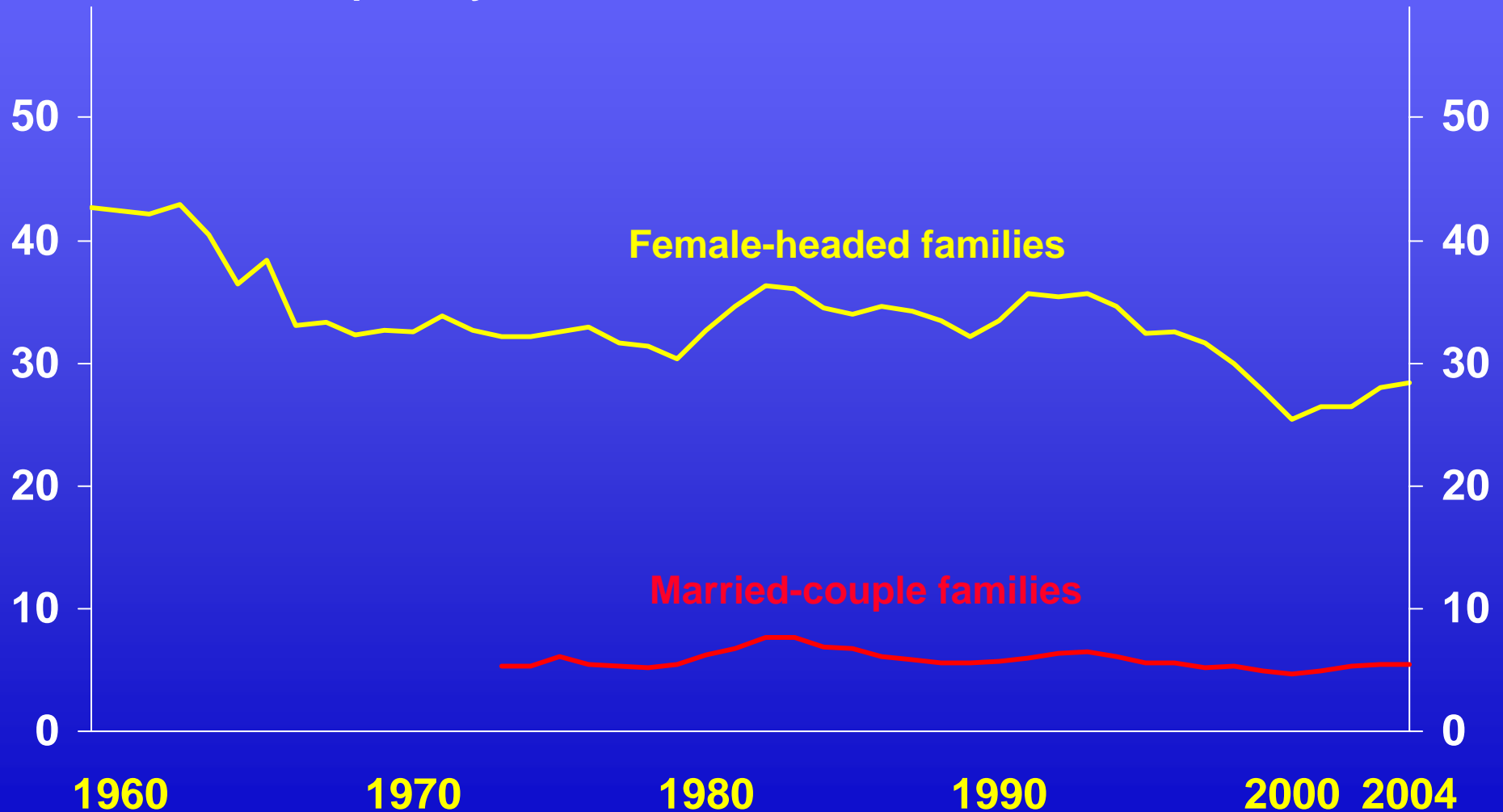
Households with children under age 18 (2003)



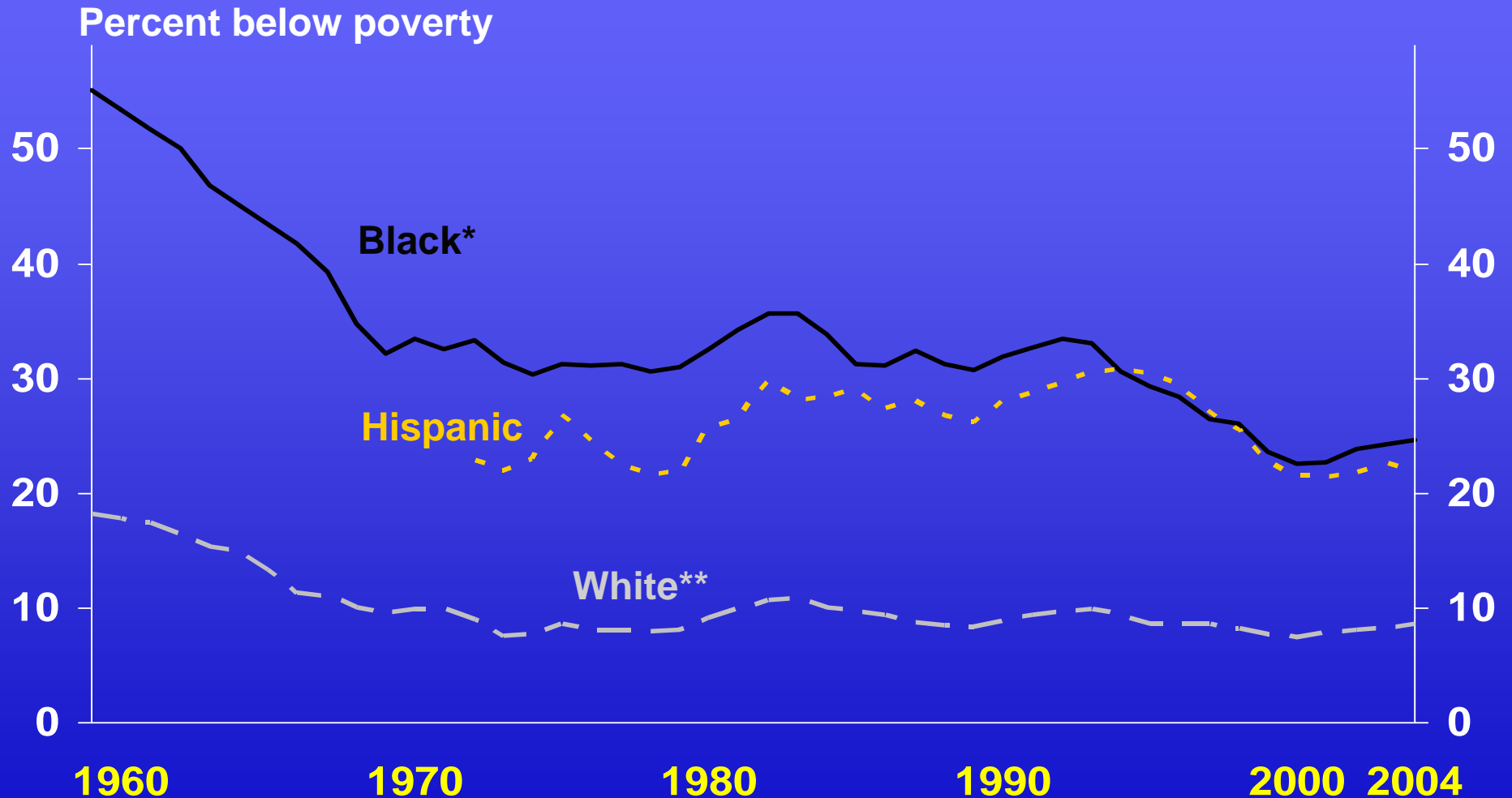
Poverty Rates by Type of Family

Poverty vs. Unemployment (1959–2004)

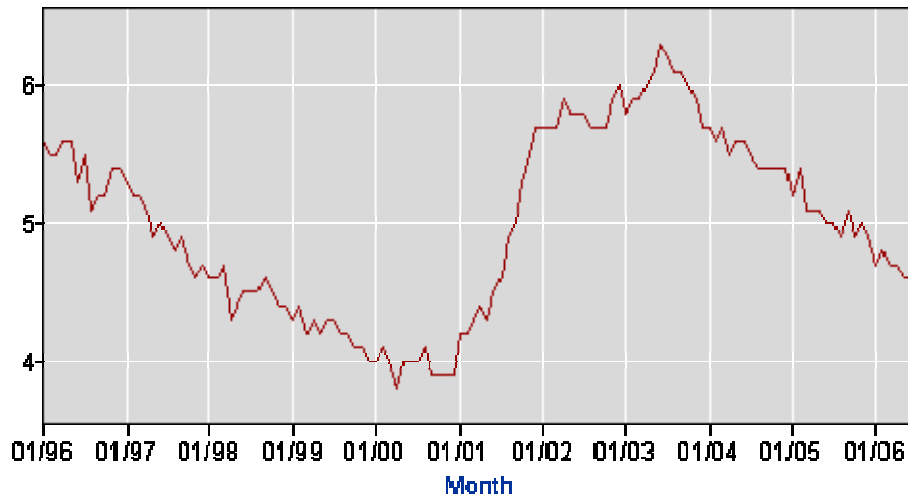
